# Free-electron gas at charged domain walls in insulating $BaTiO_3$

Hetero interfaces between metal-oxides display pronounced phenomena such as semiconductor-metal transitions, magnetoresistance, the quantum hall effect and superconductivity. Similar effects at compositionally homogeneous interfaces including ferroic domain walls are expected. Unlike hetero interfaces, domain walls can be created, displaced, annihilated and recreated inside a functioning device. Theory predicts the existence of 'strongly' charged domain walls that break polarization continuity, but are stable and conduct steadily through a quasi-two-dimensional electron gas. Here we show this phenomenon experimentally in charged domain walls of the prototypical ferroelectric BaTiO<sub>3</sub>. Their steady metallic-type conductivity, 10<sup>9</sup> times that of the parent matrix, evidence the presence of stable degenerate electron gas, thus adding mobility to functional interfaces.



olid interfaces between two distinct materials or material states are quasi-two-dimensional objects, which display uniquely distorted electronic structures and ionic displacements. Properties of such interfaces may, therefore, be entirely different from those of the parent materials. Indeed, technologically enticing phenomena were found at hetero interfaces between metal-oxides<sup>1-7</sup> and in compositionally homogeneous interfaces such as ferroic domain walls<sup>8-17</sup>. The anomalous properties at domain walls in ferroics are especially attractive for their variability. Domain walls can change positions, shapes and thereby also intrinsic properties in a controlled way so that they could be utilized inside a ready device<sup>18</sup>. So far, the reported anomalies at ferroic domain walls are mostly weak in magnitude. However, drastic property deviations are theoretically predicted at specific types of charged domain walls in ferroelectrics<sup>19-21</sup>. These domain walls represent a fascinating unexplored arena.

Ferroelectrics domain walls are nanometric-scale transitions between two ferroelectric domain states, which differ in the orientation of a switchable spontaneous polarization. As secondary order parameters like spontaneous strain are usually induced by the polarization, ferroelectrics are mostly also improper ferroelastics. Therefore, as domain walls are mobile, their geometry is naturally forced towards equilibrium with electrostatic neutrality between adjacent ferroelectric domains and towards minimal strain mismatch between ferroelastic domains. Whenever this equilibrium is slightly perturbed, the domain walls become weakly charged due to polarization divergence. This occurs during ordinary processes like domain switching or domain-wall bending by external forces<sup>15,17,22</sup>. Such weakly charged domain walls showed transient enhanced conductivity, 10<sup>3</sup> times that of the bulk, during switching in Pb(Zr<sub>0.2</sub>Ti<sub>0.8</sub>)O<sub>3</sub> thin films<sup>15</sup> and steady enhanced conductivity under illumination with above-bangap-energy photons in LiNbO<sub>3</sub> cystals<sup>17</sup>. These domain walls shown signs of metalliclike behaviour, but they are impractically unstable<sup>15</sup> or must be pinned by defects<sup>17</sup>.

An exotic family of domain walls was found in improper ferroelectrics YMnO<sub>3</sub> (ref. 23) and ErMnO<sub>3</sub> (ref. 16). These materials naturally lock ferroelectric domain walls with a wide range of orientations including stable charged configurations. Tail-to-tail domain walls in ErMnO<sub>3</sub> showed some three times the conductivity of the semiconducting bulk while head-to-head domain walls displayed a conductivity drop<sup>16</sup>. However, unlike in ordinary ferroelectrics, the spontaneous polarization in manganese oxides is a secondary order parameter induced by a structural phase transition (PT). This mechanism drives the polarization with substantially different thermodynamic forces than in ordinary ferroelectrics<sup>24</sup>. Thus, properties of charged domain walls in proper and improper ferroelectrics cannot be generally linked. For example, manganese oxides, unlike ordinary ferroelectrics, cause the unusual topological locking of the polar and antiphase boundaries and do not necessarily require compensation of charged domain walls<sup>25</sup>.

In proper ferroelectrics, the existence of such 'strongly' charged domain walls (sCDW) depends vitally upon almost perfect compensation of the polarization charge. The compensation can be provided by mobile defects, which also stabilize the domain walls, but in this case, the domain-wall properties are not expected to display exceptional new features<sup>17,26</sup>. In contrast, theory predicts<sup>19–21</sup> the existence of qualitatively different, electron- and hole-compensated sCDW in ordinary wide-bandgap ferroelectrics. These sCDW can be stable while completely breaking polarization continuity. They form head-to-head and tail-to-tail polarization divergences as illustrated in Fig. 1 leading to high concentrations of polarization charge. Formation of this bound charge is simultaneously

counterbalanced by two stabilizing factors: (i) free-carrier compensation of the polarization charge at the walls and (ii) clamping of two ferroelastic states. Thus, sCDW might be flat and mobile while covered with free carriers.

Why should these sCDW be technologically interesting? The free-charge compensation at sCDW must be almost complete in order to reduce the depolarizing field that would otherwise prohibit their formation or kill ferroelectricity<sup>19,20</sup>. For realistic parameters of ferroelectric perovskites (unless these are heavily doped), such compensation cannot be provided with the typical free-carrier concentration in these materials. Most of the screening charge originates from electron transfer across the forbidden energy gap or an external charge injection. Theoretical calculations predict that the charge compensation at stable sCDW in ordinary ferroelectrics results in the formation of degenerate quasi-two-dimensional electron gas (q2DEG) with metallic freecarrier concentration<sup>19-21</sup>. This high concentration might result in a pronounced steady metallic-type conductivity of sCDW and other properties linked to an electron gas confinement in their energy well.

While the intrinsic properties of neutral and weakly charged domain walls are being rapidly revealed<sup>10–15,17,27</sup>, sCDW remain poorly understood, especially on the experimental level. sCDW are rarely formed naturally due to their high energy<sup>20</sup> and methods of their artificial formation have been seldom investigated<sup>17,28,29</sup>. Sporadic naturally formed sCDW have been detected in unpoled thin films<sup>30,31</sup> and indirectly identified in bulk crystals<sup>28,29</sup>, but their electronic properties have hardly ever been reported.

Here we show experimental evidence for the q2DEG at stable 90° sCDW of the prototypical wide-bandgap proper ferroelectric BaTiO<sub>3</sub>. The sCDW show giant steady metallic-type conductivity,  $10^9$  times that of the BaTiO<sub>3</sub> bulk. We support the experimental findings by theory and phase field simulations, which explain the properties of sCDW and the role of sCDW-electrode junctions.

#### Results

**Experimental**. The sCDW are created by so-called frustrated poling<sup>29</sup>. An electric field, *E*, is applied to a  $(110)_c$  plate of tetragonal BaTiO<sub>3</sub> in a  $[110]_c$ -like direction. This leads to two equally preferred ferroelectric-ferroelastic domain states, Fig. 1a, which can be separated either by  $(110)_c$  neutral domain walls or  $(1\overline{10})_c$  sCDW. The theoretical energy density of sCDW is significantly larger than that of the neutral domain walls<sup>20</sup>, but their total energy in a thin plate sample can be smaller due to their smaller total surface. The sCDW are stabilized by elastic compatibility of adjacent ferroelastic states, therefore, their density can be controlled by favourable poling history and boundary conditions<sup>29</sup>.

Frustrated poling of BaTiO<sub>3</sub> samples during slow cooling over the paraelectric-ferroelectric PT led to the formation of  $(1\overline{1}0)_c$ planar sCDW, Figs 1b–e. The full Pt electrodes used for the poling were then replaced with circular Pt electrodes of 200 µm diameter and 400 µm period on the side with negative polarization charge, Fig. 1c. This configuration resulted in similar fractions of electrodes touching head-to-head, tail-to-tail or no domain walls. By measuring charge transfer between the bottom and individual upper electrodes, one can clearly relate changes in the conductances to the presence of sCDW.

The conduction between electrodes connected by tail-to-tail sCDW was almost identical to the conduction through the bulk. The conduction between electrodes touching head-to-head sCDW was reproducibly and steadily (for > 120 h)  $10^4-10^6$  times higher, Fig. 2. We confirmed this exclusive relation between head-to-head sCDW and giant conductivity by testing 30 different spots on ten different walls and on the bulk.





Figure 2 | Conduction through charged domain walls in BaTiO<sub>3</sub>.

Figures 2a,b show room-temperature I-V curves of the bulk and the cases when a single head-to-head or tail-to-tail domain wall is present between the tested electrodes. One can see, in Figs 2b,a conduction threshold at ~8 V indicating non-ohmic contact between the electrodes and the ferroelectric. Each datapoint in Figs 2a,b is acquired 1 min after step change of applied voltage, hence, the values include transient currents seen on Fig. 2c. The steady difference between conductance measured with and without the head-to-head sCDW is more than six orders of magnitude (at V = 100 V after >660 min), Fig. 2c. Assuming the thickness of sCDW is 10–100 nm ref. 21, its intrinsic conductivity is  $10^8$ – $10^{10}$  times higher than the conductivity of the bulk.

Strong evidence that the head-to-head sCDW are the objects providing free carriers for the measured current is seen at the tetragonal-orthorhombic and ferroelectric-paraelectric PTs, Fig. 3a. The  $90^{\circ}$  sCDW formed in tetragonal BaTiO<sub>3</sub> cannot exist in other phases due to their different symmetries as

illustrated in the cartoon in Fig. 3a. One can see that the electric current drops and rises by four to six orders of magnitude when cooling and heating, respectively, across the tetragonalorthorhombic phase boundary at  $\sim 3$  °C. When crossing the ferroelectric-paraelectric PT at  $\sim 110$  °C, Fig. 3a, the current drops to values typical for the bulk and remains such after cooling down to the tetragonal and orthorhombic phases. The sCDW under the measured electrodes are annihilated during the PT. All in all, the giant conductance was measured conclusively only when a head-to-head sCDW was present between the electrodes.

The current-temperature characteristics, Fig. 3, show that the conduction through head-to-head sCDW is not dominated by thermal activation like in semiconductors or ionic conductors, that is, like in the BaTiO<sub>3</sub> bulk, but has the opposite, metallic-type trend with positive temperature coefficient, Figs 3b,c. Clearly the temperature dependence of sCDW conductivity is influenced also by temperature dependence of spontaneous polarization and domain-wall width, but these factors would be minor relative to the exponential character of thermally activated conduction if the latter were the dominant mechanism.

**Simulation**. Why is this giant sCDW conduction not observed regularly? Obviously, the rare natural occurrence of sCDW due to their high-energy density<sup>20</sup> makes them practically unavailable unless they are prepared artificially. However, additional principal factors hinder the experimental access to the free-carriers at


sCDW. At low voltages, the q2DEG at head-to-head sCDW is separated from electrodes by an insulating wedge domain at the anode and an insulating gap at the cathode as seen in phase field simulation results in Fig. 4a (method in Supplementary Note 1, parameters in Supplementary Table S1) and as illustrated on the band diagram of the cross-section through a head-to-head sCDW in Fig. 5a. The calculation corresponds to zero difference between work-functions of the electrode and BaTiO<sub>3</sub>, but it is qualitatively valid for the vast majority of conductors including Pt used here. The insulating regions are formed due to flattening of electric potential profile by the equipotential electrodes. The mechanism is as follows: compensation of sCDW requires dramatic band bending when the bottom of the conduction band drops below the Fermi level at head-to-head sCDW (Fig. 5) and the top of the valence band rises over the Fermi level at tail-to-tail sCDW (Supplementary Fig. S1). Otherwise, there would be no available energy states, which could be occupied by compensating free carriers. Recurring sCDW form built-in triangle-wave potential profiles (Supplementary Figs S1 and S2) with amplitude equal to the BaTiO<sub>3</sub> bandgap<sup>21</sup>. This cannot be satisfied by the electrodes which dictate value and the (flat) profile of the potential, thus, the potential difference between sCDW and electrodes forms a transition region that is insulating and exposed to high electric field. This field has a depolarizing direction between anode and head-to-head sCDW, which nucleates the wedge-like domain (Fig. 4 and Supplementary Fig. S3) or other anti-polar domain structures<sup>21</sup>. The electric field in the poling direction is applied across the insulating gap between head-to-head sCDW and the cathode as shown in Figs 4 and 5 and Supplementary Figs S1 and S4. This situation is inverted at tail-to-tail sCDW, that is, the wedge domain is at the cathode and the insulating gap at the anode<sup>21</sup> (Supplementary Fig. S1). Both sCDW are, therefore, disconnected from the electrodes.

In most cases, the conducting path through the q2DEG at head-to-head sCDW can be established only when the wedge domain at the anode, Fig. 4a, is annihilated by the local electric field and the insulating gap at the cathode is penetrated by electron tunnelling (Fig. 5b), hence I-V curves should exhibit threshold characteristics such as those in Fig. 2b. The wedge domain at the anode is reduced upon increase of applied voltage V between the electrodes and annihilated when V > 8 V. Note that the threshold value in real system should be history and case dependent as is domain nucleation. We have observed such unsettled conduction thresholds at fresh sCDW.


The simulation results in Figs 4c-e, show the situation where the electric potential (V = 12 V) already connects the q2DEG with the anode (schematics in Fig. 5b). On the other hand, a permanent insulating gap remains between the q2DEG and the cathode, Fig. 4. However, when the q2DEG is connected to the anode, Figs 4c-e and Fig. 5b, the applied voltage drops entirely over the junction at the cathode, exposing the insulating gap to giant electric fields, theoretically up to ~10<sup>5</sup> V mm<sup>-1</sup> when 10 V is applied. A lower bound conductivity estimate, given by sole Fowler–Nordheim tunnelling through the insulating gap (Supplementary Note 2) reaches the experimentally measured values, that is, ~10<sup>-6</sup> A at 100 V, when the barrier height is up to 2 V and the gap thickness is up to 90 nm, thus, providing sufficient current for realistic barrier parameters (results summarized in Supplementary Figs S5–S7).

Clearly this tunnelling can be further enhanced by defectassisted charge transfer mechanisms<sup>32</sup> and by additional reduction of the barrier thickness due to accumulation of usually present oxygen vacancies, Vö, near to the Pt electrodes<sup>33</sup> (Supplementary Fig. S4). This might happen especially under poling fields, which drive the positively charged Vö towards the cathode. The accumulated Vö narrow the barrier<sup>33</sup> and provide empty energy levels ~ 0.4 eV below the conduction band of BaTiO<sub>3</sub> for additional trap-assisted tunnelling, which might result in significantly higher charge transport than the sole Fowler–Nordheim tunnelling. As the tunnelling current has a small negative temperature coefficient, we associate the measured current–temperature dependence in Fig. 3 to the sCDW themselves.

One can see in Fig. 2a,b, that tail-to-tail sCDW do not exhibit apparently higher conductivity compared with the bulk even though, in defect-free material, they should form a conductive quasi-two-dimensional hole gas<sup>21</sup> (Supplementary Fig. S1). The reason for low conductivity of tail-to-tail sCDW is not positively identified, but according to our simulations (Supplementary Note 1), free-carrier concentration at these walls can be suppressed by accumulation of Vö. A small initial concentration of Vö  $(10^{18} m^{-3})$  is sufficient to accumulate at

tail-to-tail sCDW and substitute screening holes (Supplementary Fig. S2). The calculated accumulation time is <10 h, which is short compared with the time between sCDW formation and their characterization in our experiments. On the other hand, Vö

deplete from head-to-head sCDW leaving the q2DEG intact and available for conduction (Supplementary Figs S2 and S4). All in all, accumulation of Vö in theory suppresses conduction through tail-to-tail sCDW while it enhances the electron transfer through the barrier between the q2DEG at head-to-head sCDW and the Pt cathode.

Note, that insulating barriers between electrodes and either tailto-tail or head-to-head sCDW in defect-free material would be theoretically reduced to zero and form ohmic contacts when the electrode material had a work-function, respectively, smaller or bigger than BaTiO<sub>3</sub> by more than half of the BaTiO<sub>3</sub> bandgap, that is, by more than  $\sim 1.5$  V. Most conductors have their workfunctions below this limit. Additionally, the work-function, especially in metal-oxides is an extremely sensitive measure of the surface state, which is strongly dependent on surface preparation and the measurement technique, making it hard to control in experiments. However, according to the text-book values, Pt with its exceptionally high work-function  $\sim$  5.7 V which is 1.5 V more than  $\sim$  4.2 V of BaTiO<sub>3</sub> should support spontaneous formation of tail-to-tail sCDW and create their ohmic contact. In reality, we observed neither spontaneous sCDW formation nor their ohmic contact with electrodes, which is not surprising when work-function sensitivity and drift of Vö is considered.

#### Discussion

In summary, our experiment showed that  $90^{\circ}$  head-to-head sCDW in the classical ferroelectric BaTiO<sub>3</sub> are stable and exhibit qualitatively pronounced metallic behaviour with a steady conductivity ~  $10^{9}$  times the bulk DC conductivity of BaTiO<sub>3</sub>. Our analysis, supported with phase field simulations, relate the observation to the presence of a degenerate q2DEG, which is held in a potential well formed by the polarization charge.

In contrast to the phenomenon observed in improper ferroelectrics<sup>16</sup>, where 10<sup>1</sup> times enhanced conductivity was observed at tail-to-tail domain walls, the almost perfect compensation of polarization charge by degenerate free carriers (in the absence of defect compensation) is indispensable for the existence of sCDW. While the proper ferroelectricity in typical perovskites would be suppressed by the depolarizing field that is created in the absence of

the screening charge at charged domain walls, the improper ferroelectricity would not be suppressed in such a case as it can lower its energy by reduction of polarization. Thus, sCDW in pure ordinary ferroelectrics must exhibit giant conductivity via degenerate free carriers by default, while the conductivity of locked charged domain walls in improper ferroelectrics is case dependent.

The concept shown above could be implemented in other proper ferroelectrics. Yet, writing stable charged domain walls in the classical ferroelectric insulator  $BaTiO_3$  as shown here is of an extra appeal as, unlike most of the applied ferroelectrics, this material is lead-free and composed of abundant elements. In addition, charged domain walls in  $BaTiO_3$  are predicted to be exceptionally thick<sup>21</sup> making it a suitable material for fundamental studies. Additional intriguing properties of the q2DEG are likely to exist also in sCDW. Emerging oxide electronics that use the q2DEG and other hetero interfacial properties<sup>7,34</sup>, might also incorporate the new phenomena described here, where q2DEG could be electrically displaced, erased and recreated inside ready devices, ultimately adding interface mobility to future electronic elements.

#### Methods

**Sample preparation.** Undoped (110)<sub>c</sub> plates of BaTiO<sub>3</sub> were cut into  $5 \times 5 \times 0.5$  mm<sup>3</sup> pieces and lapped to 200 µm thickness with diamond films of roughness from 15 to 0.1 µm. The samples, cleaned with acetone and isopropanol, were sputtered with 12 nm thick Pt electrodes on [110]<sub>c</sub> surfaces. Samples were heated while observed with a polarization microscope in transmitted light. Slow (0.2 °C/min) heating from 100 °C while switching on and off 350 V (~1 switch min <sup>-1</sup>) allows optical identification of (i) zero field and (ii) the field-induced PTs. After heating up to 0.7 °C above the field-induced PT, the samples were slowly (0.1 °C min <sup>-1</sup>), without electric field, cooled up to ~0.1 °C below the field-induced PT temperature. Then, 350 V was rapidly applied inducing the PT and a periodic structure with (110)<sub>c</sub> planar sCDW. This process is strongly sensitive on poling conditions, often creating walls, which do not pass through the whole sample or form zig-zag-like neutral walls. The Pt electrode on the anode was removed by 1 µm diamond paste and replaced with sputtered 150 nm thick, 200 µm diameter circular Pt electrodes with 400 µm period.

**Conductivity measurement.** At room-temperature, I-V characteristics between 30 different top electrodes and the bottom electrode were measured with a Keithley 6517A electrometer. Measurement was conducted in a dark and electrically shielded box. Voltage was applied in steps (seen in Figs 2a,b) and current was averaged between 60 and 70 s later. The current-temperature measurement was done in a DELTA 9023 chamber. Temperature was captive when it fluctuated <10% for more than 10 s, then, current was averaged for 20 s.
